4.1 : Camping in Llanddwyn : Illegal camping the police will make periodic visits to the beach to dispel the campers.

4.2 : Eglwys Bach Handrails : The handrails have been installed in Eglwys Bach Community Center in Newborough.

9 : COUNTY COUNCILLOR REPORTS : Councillor Peter Rogers and Councillor Brian Owen attended a meeting with the Highways department of Anglesey County Council to discuss the ongoing problems with parking and traffic in Newborough and it was agreed to all the traffic prohibitions and the yellow lines and for better signage at the lane down to the stepping stones. Councillor Dennis Owen brought up the parking problems outside the shop in Llangaffo and the problems with the mirrors at the junction by the shop. Highways confirmed the speed limit in Dwyran will be reduced to 40mph. Councillor Brian Owen agreed to enquire with the council's waste department if when new bins are required in lieu of damaged ones do residents have to pay for them.

13. ANY OTHER MATTERS :

13.1 : Councillor Jane Roberts reported the reactive speed sign in Llangaffo is not working and is unsafe. Resolved to write to report to Highways.

13.2 : Councillor Dennis Owen raised concerns about parking outside the shop in Llangaffo and the mirrors at the junction are not working properly and reported the problem with dog fouling in Llangaffo Resolved to write to Anglesey Council to report the various problems.

13.3 : There were concerns about the speed of traffic by the railway bridge in Llangaffo and that maybe visitors would not know the layout of the road and it was suggested that maybe cheverons on the road might be useful. Resolved to write to the Council to enquire about the possibility of having these cheverons.

13.4 : Councillor D.Roberts reported that the owner of the Ferry House in Brynsiencyn had a no parking road closed sign it was requested that he remove it. Councillor Roberts also reported that there was a damaged telephone pole on the road down to the Mermaid and that the hedge at the junction in Dwyran needed trimming back. There was also a problem with children playing with the bins at Penbryn surgery in Dwyran Resolved to write to report all of these problems.

13.5 : Councillor Sykes reported there is no green bin in Milgwyn Cemetary Resolved to write to the enviromental department to request one.

13.6 : Various hedges and verges were reported and it was resolved to ask A.Thomas to cut them .

13.7 : A letter of thanks was received from the Church in Llangaffo thanking the community Council for the grass cutting works in the churchyard.

13.8 : Councillor T.Hughes requested a meeting with the highways department to discuss the road down to the stepping stones : Resolved to invite the Highways Dept to a meeting with the councillors and residents. Councillor Hughes informed the Community Council that Parc y Plant committee in Newborough was disbanding.
